- Professional Practices and Responsibilities certificate. Note: If you hold an MCA Deck Officer's Certificate of Competence as detailed in MSN 1856 and 1858, you do not need to take the PPR course. - RYA SRC certificate or another acceptable GMDSS Marine Radio Operators certificate

Please note: If you are submitting an ML5 Medical Report form and certificate with your application and the Doctor has entered any "yes" ticks in sections 1-9 your Medical will need to be referred to the MCA and they will not accept any Medicals which are more than 1 year old. Please contact the RYA Certification Department for further details on 023 8060 4146.

Please note: Your commercial endorsement cannot be Fast Tracked if your ML5 Medical requires referral.

4. STCW 78 ENDORSEMENT

The STCW 78 endorsement is for holders of the RYA Yachtmaster Offshore and Yachtmaster Ocean Certificates of Competence working under non-UK maritime authorities. It requires you to take 4 additional courses:

Personal Survival Techniques (STCW A-V1/1-1)

Personal Safety and Social Responsibilities (STCW A-V1/1-4)

Elementary First Aid (STCW A-V1/1-3)

Fire Fighting and Fire Prevention (STCW A-V1/1-2)

The following wording will appear on your certificate:

The certificate holder has completed training under the STCW code A- VI/1 Para 2.1. This certificate is valid for use as Master of yachts of up to 200gt on commercially and privately registered yachts until (date of expiry).

The STCW convention requires Personal Survival Techniques and Fire Fighting and Fire Prevention to be refreshed every five years. The MCA code of practice requires first aid training to be refreshed every five years.

Please note that if you wish to add the STCW 78 endorsement at the point of applying for your commercial endorsement you will not be required to pay an additional fee. However, should you wish to add the STCW 78 endorsement whilst holding a current commercial endorsement then a fee of £15.00 will be required.

The Maritime and Coastguard Agency publish a number of Codes of Practice covering the commercial operation of vessels less than 24m in length and large yachts. Please refer to the relevant code of practice to check your qualification is appropriate to the particular type of operation you plan to undertake

I confirm that I understand my responsibilities with regard to maintaining an appropriate medical fitness certificate and first aid certificate during the period of validity of my commercially endorsed certificate. I also accept that my medical information may be referred to an the medical team.

NOTES FOR APPLICANTS

The commercial Endorsement is valid for 5 years however, you must ensure that your medical fitness certificate (ML5 or ENG1) is always in date. After 5 years you will receive a reminder to renew your endorsement and we will require a new medical fitness certificate and evidence of active service declared.

The UK's Small Commercial Vessel Codes of Practice detail the minimum first aid qualifications required as either the RYA First Aid, STCW Elementary First Aid or Sea Fish first aid. Any course for those responsible for first aid on board must cover the use of Category C medical stores as detailed in MSN 1768 (M+F). You are personally responsible for ensuring that you hold any additional certification such as higher First Aid or Radio Operator's certificate dictated by the specific regulations governing the vessels on which you serve.

RYA Instructors and Examiners who are re-tested practically to re-validate do not have to record their active service.

PLEASE NOTE: The ML5 can only be issued by a UK GMC Registered Doctor. The ENG1 Medical is only issued by an MCA Approved Doctor. If you require an ENG1 Medical please contact the MCA on 023 8032 9100 or visit their website.

Please allow 21 days for the commercial endorsement to be issued

FAST TRACK SERVICE: For a small additional charge we can guarantee a two working day turnaround from the date we receive the application. If you require this service, please clearly mark your application with FAST TRACK and include either £30 for non RYA members, £20 for RYA members, £15 for RYA accredited members, £10 for RYA gold members and free for Life members. This fee should be paid by cheque, payable to the RYA or by completing the payment form on this application. **Please note:** If your ML5 Medical requires referral then we are unable to fast track your application.

If you require your documentation to be returned by Special Delivery you will need to enclose the relevant pre-paid envelope which can be obtained from your local Post Office. Please ensure the envelope is the correct size to enable us to return all your supporting documents along with your A5 certificate and leather wallet.
