

APPLICATION FOR RE-VALIDATION OF COMMERCIAL ENDORSEMENT
RYA/MCA CERTIFICATE OF COMPETENCE OR
POWERBOAT CERTIFICATES / CERTIFICATE OF SERVICE

All certificates (whether of Competency or Service), Boatmasters Licences and Local Authority Licences must be revalidated every five years. To revalidate, the applicant must prove at least 150 days of actual sea service on appropriate vessels during the previous five years and be in possession of a valid medical fitness certificate.

Applicants for revalidation who are not able to prove the requisite sea service but are able to demonstrate that during at least half of the five year period they have been employed on duties closely associated with the management and operation of one or more of the appropriate types of vessels, may have their Certificates or Licences considered for revalidation.

If a photocopy of your Medical Certificate of Fitness has been provided, then this will not be returned and will be confidentially destroyed. If you have an ML5 Medical that is not version, MSF 4112 REV 02/23 then the original Certificate of Fitness will be required as this needs to be endorsed by the RYA.

- *****Optional***** - if you hold all 4 basic STCW training modules we can also endorse an RYA Yachtmaster Offshore or Ocean qualification to indicate that you have been trained under the STCW convention. In order to request this please include evidence of the 4 STCW basic training modules at the time of submitting your application.

Please note: Your Commercial Endorsement will be renewed from the date of processing for a maximum of 5 years.

From January 2017 the STCW Fire Fighting & Fire Prevention, and Personal Survival Techniques courses require updating every 5 years to be valid for use for the STCW endorsement. Certificate holders must hold a current first aid certificate for the duration of their commercial endorsement. All First aid certificates with no expiry date listed must be updated 5-yearly for the purpose of a commercial endorsement

****** If you are applying outside the United Kingdom you will be required to obtain an ENG1 or alternatively you can contact the Maritime Authority of the respective country who will inform you of the recognised equivalent.

Please note: The ML5 Medical Report Form and Certificate can only be completed by a UK GMC registered Doctor and must be the most recent version, which is currently MSF 4112 REV 02/23.

If your Doctor has entered any "Yes ticks" on your ML5 Medical Report form then your ML5 Medical will need to be referred onto the MCA to be reviewed and you will be required to complete Part D the Medical Review on page 12/16 of your ML5 Medical to provide the RYA with additional information to submit to the MCA. The MCA will not be able to give a decision on the issue of your Commercial Endorsement if this section is not completed in full. If your ML5 medical is more than three months old at the time you submit your medical for referral, a declaration will be required to confirm that no medical details have changed. The declaration will be emailed to you. Please note the MCA will not accept any ML5 Medicals which are more than one year old.
