APPLICATION FOR EXAMINATION FOR THE CERTIFICATE OF COMPETENCE IN RADIOTELEPHONY GMDSS SHORT RANGE CERTIFICATE (SRC)

The examination takes the form of a practical and written test on radiotelephone voice procedures, operation of a Class D DSC controller and regulations governing the use of a VHF Marine band radiotelephone in the Global Maritime Distress and Safety System, with particular emphasis on distress and urgency procedures.

THE SHORT RANGE CERTIFICATE

This certificate authorises the holder to use a radiotelephone on the VHF international frequencies of the Maritime Mobile band including channel 70 for digital selective callings. The SRC is intended for use in vessels of under 300 gross registered tons which voluntarily fit GMDSS equipment.

OTHER RADIO OPERATOR QUALIFICATIONS

The Short Range Certificate does not authorise the holder to use MF or HF equipment or act as radio operator on a vessel which is required by law to be fitted with radio equipment for participation in the GMDSS.

ELIGIBILITY TO SIT THE EXAM

Candidates of any nationality or residency are eligible to take the UK SRC exam provided they are 16 years old or older on the day of the exam. There is no age limit on the attendance of an SRC training course.

Exam candidates should have one of the following three qualifying criteria prior to the exam taking place:

1. Satisfactorily completing a recognised classroom based SRC course, delivered through a RYA recognised training centre.
2. Satisfactorily completing the RYA's online SRC course, delivered through an RYA recognised training centre.
3. Holding an acceptable non-GMDSS maritime radio operators certificate such as the RYA's Restricted VHF certificate.

Candidates should contact their local RYA recognised training centre for course and exam details. Candidates following option three are strongly recommended to attend some form of coaching/training at an RYA recognised centre prior to taking the exam.

PHOTOGRAPH

All applicants must provide, at the time of the exam, a passport size (45mm high by 35mm wide) colour photograph with their name clearly printed on the back.

EXAMINATION FEES

An examination fee of £60 is payable to the RYA. Payment details must be completed prior to the commencement of the examination.

FAST TRACK SERVICE

For a small additional charge we can guarantee a two-day working turnaround from the date we receive your application.
